B-E School Board hears financial report for January

The Brandon-Evansville School Board at its Feb. 12 meeting received a report on the district's finances for January.

The report showed the district on Jan. 1 had a beginning balance of \$4,941,969.50.

Receipts for the district totaled \$1,783,079.94. The largest amount was from the Minnesota Trust in the amount of \$1,031,058.11. This money is being used for the district's building project.

The district received \$604,475.99 from state and federal resources and \$99,461.36 from local sources.

Other receipts included \$26,985.96 from Douglas County and \$21,098.52 in interest.

Disbursements for the district totaled \$3,678,176.48. January wire transfers were \$1,646,937.46.

amounted to \$1,061,864.30.

The district's net payroll disbursement for January was \$247,658.95 with January checks amounting to \$89,705.27. The other disbursement for the district was \$706.50 for bank charges.

The report showed the breakdown of each fund's cash balance for the district.

The general fund had a balance of \$3,405,968.24. The community service fund balance was \$175,713.27.

The district's debt service fund was \$163,663.49 with the student activities fund showing a balance of \$87,775.98.

The food service fund had a deficit balance of \$114,062.46 while the building construction fund had a deficit of \$40,881.56.

I ne bank account balances for the largest disbursement at the district include \$132,299.13 at First Security Bank, Evans-End of January checks ville with \$1,881,764.35 at Bremer Bank, Brandon.

The district also has \$145,883.16 in a money market account at First Security Bank and \$1,518,230.32 in the Minnesota Trust.

The district's ending balance forthemonthwas\$3,678,176.96 with the prior year's balance at \$3,428,741.32.

The district also received several donations for the month.

Brandon to hold hearing on abatement

DNR classifies 13 high-risk invasive species

The Minnesota Department of Natural Resources has classified 13 high-risk invasive aquatic plants, fish and invertebrates as prohibited invasive species.

The DNR classifies invasive species as prohibited to prevent their introduction and spread in Minnesota and to protect the state's environment, economy, natural resources and outdoor recreation. It is unlawful to possess, import, purchase, transport or introduce prohibited invasive species, except under a DNR-issued permit for disposal, decontamination, control, research or education.

The prohibition on 12 of the 13 species is effective immediately, with publication of the new listings in today's State Register. Jumping worms will be prohibited invasive species effective July 1, to provide additional time for outreach to businesses and others who may be impacted by the rule change.

The new species and the reasons for listing the species are summarized below. More information on these species can be found on the Invasive Species Rulemaking webpage.

• Jumping worms have negative impacts on plants and soils. Jumping worms have been confirmed in some Minnesota urban areas but not in most of Minnesota. Listing jumping worms as prohibited invasive species will reduce their spread in Minnesota by making sales of jumping worms illegal. This measure also strengthens

regulations so that legally sold worms are not contaminated with any jumping worm species.

- Non-native common reed reduces biological diversity by crowding out native plant and animal species. The rule does not apply to Minnesota's native subspecies of common reed.
- Mitten crabs, Nile perch, snakehead fish, and walking catfish are now classified as prohibited invasive species in Minnesota due to their environmental impacts and for consistency with the federal injurious wildlife species list.
- Yellow floating heart (an aquatic plant), tench (a fish), golden mussel, and marbled crayfish are all identified as "least wanted" species by the Conference of Great Lakes and St. Lawrence Governors and Premiers Aquatic Invasive Species Task Force. Adding these regional priority species to Minnesota's prohibited invasive species list will help to prevent their introduction and spread.
- Golden clams can block water intake pipes and interfere with substrate needed by native species. Populations of golden clams have been found in some Minnesota waters. Classifying this species as prohibited will help prevent further spread in the state.
- Tubenose gobies are nonnative to North America and have the potential for negative impacts. The western tubenose goby is already listed as a prohibited invasive species in

Minnesota, and several other species in the genus are difficult to distinguish from one another. Listing the genus will help prevent the introduction and spread of other tubenose goby species.

• Eastern mosquitofish. Eastern mosquitofish have been stocked for mosquito control in other states in the U.S. and have become invasive in places they were introduced. Eastern mosquitofish are not known to be in Minnesota. Adding eastern mosquitofish to the prohibited invasive species list will reduce the risk that this species would be introduced to the state.

The DNR has authority to protect Minnesota's environment, economy and natural resources from potential harm from non-native species of wild animals and aquatic plants. These classification changes are part of the DNR's ongoing work to assess the risk of nonnative species. These additions to the prohibited species list follow a public review and input process as part of formal rulemaking.

Other prohibited invasive species in Minnesota include zebra mussels, Eurasian watermilfoil and silver carp. A complete list is available on the DNR invasive species laws website.







DNR determines no cormorant control needed on Pelican Lake

The Minnesota Department of Natural Resources has determined that cormorant population control is not currently warranted at Pelican Lake in Grant County. The decision follows data showing walleye numbers in Pelican Lake improved in 2022 and 2023.

"When the Pelican Lake walleye population declined sharply in 2021, the DNR looked at the cormorant population as a potential factor," DNR Fisheries Northwest Regional Manager Marc Bacigalupi said. "The good news is that the 2022 and 2023 walleye year-classes appear to be strong. The DNR will survey cormorants and fish in Pelican Lake again in 2024. We have an ongoing commitment to manage these fish and cormorant populations."

Bacigalupi also thanked everyone who participated in

a 2023 public input process on fish and cormorant population management alternatives at Pelican Lake.

The 2023 gillnet catch rate in Pelican Lake rebounded to 7.5 walleyes per net, just below the management plan goal of eight walleyes per net, from 5.3 walleyes per net in 2021.

Cormorants on Egret Island in Pelican Lake were counted in 2022 and 2023. Nest counts are lower than previous counts from 2015 and 2020.

The DNR will be developing an adaptive monitoring and management plan for the Pelican Lake fishery and Egret Island cormorant colony. An adaptive management plan is a process that identifies when management may be warranted, along with an approach to monitor the outcomes of any management.

Input on Green Fertilizer wanted by MDA

Through a request for information (RFI), the Minnesota Department of Agriculture (MDA) invites eligible cooperatives and other interested stakeholders in providing input to help the agency in designing a new Green Fertilizer Grant Program and in assessing business readiness of the green fertilizer industry in Minnesota.

During the 2023 session, the Minnesota Legislature appropriated \$7 million to the MDA for a Green Fertilizer Grant Program. The program is intended to provide financial support to Minnesota agricultural and rural electric cooperatives investing in green fertilizer production facilities, helping reduce greenhouse gas emissions and increase the use of renewable energy in the agriculture sector.

The Green Fertilizer Grant Program is a financial tool that can be combined with federal funds like the Inflation Reduction Act Clean Hydrogen Production Tax Credit

or Department of Energy loan programs

to de-risk and incentivize development of the local green fertilizer industry.

For this program, green fertilizer is defined as any nitrogen-based fertilizer that contains hydrogen produced via electrolysis powered by renewable energy.

The full RFI can be viewed on the MDA's Green Fertilizer Program web page. Responses are due by 5 p.m. Central Time on Thursday, March 14, 2024, via Microsoft Forms.

City organizations want more funding for infrastructure, EMS systems

Two organizations that represent Minnesota cities outside the Twin Cities region hope the Legislature will address several challenges facing their member cities, including stress on Emergency Medical Systems and infrastructure needs.

The Coalition of Greater Minnesota Cities and the League of Minnesota Cities, whose requests often overlap, are asking that funding for those two areas be included in this year's bonding bill.

Funding for EMS

One of those requests is for around \$120 million to help EMS programs function.

"Over the last two years, our communities have been literally ringing alarm bells about the fragility of the system," Bradley Peterson, CGMC's executive director, said during a Zoom call about the organization's legislative priorities. "Reimbursements from Medicare and Medicaid and private insurance are simply not keeping up with the services provided. The fee-



for-service model is, frankly, in many of our communities, not sustainable."

Also on the call was the mayor of Virginia, a city where demand for EMS services is high. The Iron Range town has 38 full-time fire EMS employees that cover around 640 square miles in northeastern Minnesota, mayor Larry Cuffe Ironid

A total of \$3.8 million from the city's budget goes toward EMS, though last year the city only recovered around \$1 million from Medicare reimbursements. For the last seven years, Cuffe said the city's EMS program has run at a deficit.

He said the support the state offers to essential services don't apply to EMS systems. And while the state allows the city to increase taxes on residents for those services, there isn't overwhelming support for that idea

"The citizens of Virginia are bearing the cost of the entire coverage," Cuffe said. "It is imperative that the state acts now because if this is a crisis, that will have life-threatening long-term consequences for our children, for our families and for our communities at large."

Other cities are experiencing that same stress. In other areas of the state, EMS systems face staffing shortages, with many people leaving the profession, Bradley said.

"The challenges to the sustainability of our EMS services are mounting. This already fragile system is at a breaking point. EMS closures and consolidations have been on the rise throughout the state since 2001, and without state invest-

ment the future will continue to look bleak," Rick Schultz, the mayor of St. Joseph, said during the CGMC press conference earlier this month.

The coalition has asked for \$120 million for EMS systems. Several other associations, like the League of Minnesota Cities, have backed their proposal.

"We're hearing about services in Greater Minnesota that are contemplating shutting down. In the metro area, we have a lot of frustration around accountability for response times and other issues," said Anne Finn, the intergovernmental relations director for LMC. "I think the most pressing need here is the need for funding."

There's currently an EMS task force in the Legislature. Last week, the task force met and discussed challenges with reimbursement rates. Grant Hauschild, DFL-Hermantown, said at the task force meeting that the problem is uniquely affecting rural areas because in areas that don't have private EMS systems, the responsibility of paying for licensing falls on cities.

"I do think that this is a distinctly rural challenge ... from a financial perspective it feels like the weight is on our rural communities," he said. "There is certainly a short-term crisis that we need to figure out – my hope is this session – at least for some of those most targeted areas where this is a big crisis."

Infrastructure and pollution control

Both CGMC and LMC are asking for the bonding bill to support the infrastructure needs of the cities, putting funds aside for municipal water and wastewater infrastructure, roads, bridges, and other projects.

The coalition has asked that the Legislature focus on pollutant mitigation – improving the wastewater systems to prevent pollution. It asked for \$299 million to go toward water and wastewater programs.

"It's a big number, but it's a big need," Peterson said.

One potential project that could benefit from that funding is a wastewater treatment plant in Albert Lea. Its city administrator said the aging plant needs around \$80 million for upgrades – and wastewater infrastructure grants and loans would help offset the cost.

The governor's proposed capital investment plan—which was presented to the capital investment committee last week—sets aside \$109 million for water infrastructure loans and grants, with \$18 million for new grants to address contaminants in drinking water.

Finn said the LMC advocates for large pots of funding for

infrastructure that cities can spend how they choose.

"The bonding bill this year, we understand that there is limited debt capacity for the state so we have to be realistic about how large or not large the bonding bill's going to be," she said.

The LMC has 12 legislative priorities this session. Housing is one of the other top ones. The league wants to work on policies that allow cities to address their specific housing needs with more resources, and they want to prevent policies that may create overly broad statewide mandates related to housing.

Focus on the basics

Peterson said the CGMC is urging the Legislature to focus on the issues of infrastructure and EMS delivery issues as the cities are still working on implementing the bigger policies that passed last year.

He asked that issues of development, zoning and housing wait until 2025 – and that local leaders be given some time to fix what they find to be pressing in their communities.

"From our perspective, for 2024, what the Legislature needs to do is pump the brakes on significant new policy and focus on the basics: pass a bonding bill that invests in core infrastructure around the state to shore up our EMS system and do very little else that's going to impact cities or city operations," Peterson said.

Fish house removal date is March 4

Most fish house owners in the southern two-thirds of Minnesota already have removed their fish houses from the lakes, given poor ice conditions and forecasted warm weather. The Minnesota Department of Natural Resources reminds anyone who still has a fish house on the ice to start planning for its

The statutory shelter removal deadline for the southern twothirds of the state is 11:59 p.m. on March 4. In some areas, lakes are almost totally open. Others are difficult to access due to ice already pulling away from the shoreline, while on others the ice is degrading rapidly.

"Safety is the top priority, and we are pleased that many bodies of water already are clear of ice shelters," said Col. Rodmen Smith, DNR Enforcement Division director. "However, there are still fish houses on some lakes affected by this first removal deadline, and we encourage people to pay attention to the forecast as they make their removal plans."

If shelters aren't removed by the deadline, they may be confiscated and removed, or destroyed by a conservation officer. Shelters may not be left at public accesses, and no trash or other materials – including wooden blocking materials may be left on the ice.

As they venture out, anglers

always should keep in mind that ice conditions vary widely, that ice is never 100% safe, and that they should check the ice thickness for themselves.

The removal deadline for shelters in the northern onethird of the state is 11.59 p.m. on March 18, though the DNR urges people to monitor ice conditions and consider removing shelters in advance of the deadline. Exceptions to the removal deadlines are Minnesota-Canada border waters (March 31), Minnesota-South Dakota and North Dakota border waters (March 5), Minnesota-Wisconsin border waters (March 1) and Minnesota-Iowa border waters (Feb. 20).
