B-E's Raising A Reader program receives award

The Minnesota Association for Family and Early Education (MNAFEE) announces an Innovative Programming Award winner. The award acknowledges MNAFEE's appreciation of contributions to children, parents, and families and the publicly funded programs that serve them.

The Raising, a Reader Early Literacy Program from the Lakes Country Service Cooperative (LCSC) Brandon-Evansville Pilot was chosen as a winner of the MNAFEE Innovative Programming Award for 2024.

Based on a national model, the program involves reading take-home book bags and school-based parent-child activities.

The Raising A Reader Early Literacy Program was recognized at the MNAFEE Annual Conference in St. Cloud on April 11. Beth Achter, LCSC ECFE regional coordinator, and Deb Berry, an LCSC early childhood teacher who was instrumental in developing the Brandon-Evansville pilot program, accepted the award.

From the beginning of the program, it was important that the mission of Raising A Reader aligned with the mission of LCSC and that it would be a program benefitting all communities. Driving the initiation of the program were statistics showing that before the pandemic, Brandon-Evansville had 64 percent of third-grade students reading at or above

grade level on the Minnesota Comprehensive Achievement Test (MCAT), whereas scores dropped to 39 percent in 2021-22 and 50 percent in 2022-23.

LCSC shared its vision and the need to address the issue throughout the community. A local bank was considering investing in the program through their LA Amundson Ohana Foundation. To enhance understanding of the program, an Early Childhood Family Education (ECFE) class went to the bank's lobby to demonstrate first-hand the types of play and literacy activities families participate in through the program.

The Evansville Historical

Foundation and the Douglas County Early Childhood Initiative also provided financial support to allow LCSC to become an affiliate of Raising A Reader.

About the award Berry said: "I am so grateful for all the local support that we have gotten for this program the past three years. It is truly an honor to work alongside such wonderful people to better our communities together."

Teachers, administration, and school board members at Brandon-Evansville School were informed about the project's involvement, and the school became a pilot site

involving 80 students in the Early Education Department.

Raising A Reader takes a family, school, and community collaborative approach, involving children starting at birth and continuing through second grade. The official launch was in the fall of 2021, with a trial run involving a few home - and center-based childcare centers in the summer of 2021.

Currently, there are 165 students involved; factoring in other family members, it's estimated that the program impacts approximately 735 people, more than half of the local population of roughly 1,300.

REA holds annual meeting to elect directors, award scholarships

Runestone Electric Association held its Annual Meeting on Thursday, April 25, at the Alexandria Area High School Performing Arts Center. Board of Director seats were determined in Districts 2 and 5, and scholarships were awarded to 26 students.

Runestone Electric's bylaws allow for uncontested director elections to be elected by acclamation. In District 2, Barbara Johnson ran unopposed and was reelected, and in District 5, Mike Loken ran unopposed and was reelected.

Board President Andy Anderson and CEO Al Haman reported on the cooperative's activities and financial con-

dition during the business meeting. "Safety is a priority at REA. The board, management, and most importantly, our employees take safety very seriously in everything they do," said President Anderson. He also highlighted the highly successful Operation Round Up program, the Member Advisory Council, and the Cooperative Network Builder Award recently presented to District 3 Director Audrey Hjelle.

"At year-end, the cooperative's total assets were \$103 million. That includes plant assets like the office and warehouse, lines, poles, and transformers. All our ratios exceed lending requirements. The cooperative finished 2023 with 231 new services built," said CEO Haman. Minnesota's new carbon-free by 2040 law, MISO's responsibility for electric reliability and management of the wholesale power markets, renewable energy systems owned by REA members, and electric vehicle use in the REA service territory were also discussed in the CEO Report.






The team made the semifinals in the Section 6A tournament however they lost by a minimal margin to the eventual section champs BHV-PP.

Understanding Fairy Rings in Your Lawn

Have you noticed circular patches of greener grass in your lawn? It's not uneven fertilizer but fungi feeding on decomposing matter like old tree stumps, leaves, or roots, releasing nitrogen. This phenomenon is called

a fairy ring.

Fairy rings are circular areas of abnormal turf growth, commonly found in lawns with elevated organic matter or after tree removal. Their mysterious, circular appearance has fascinated people since ancient

May reveals second and third brightest stars in the night sky

In May the evening sky ushers out the bright winter stars and nudges Leo, the lion—the most prominent spring constellation—toward the western exit. Nightfall comes late, but when it does it reveals the second and third brightest stars in our

High in the southeast blazes Arcturus, the brightest star in the northern hemisphere of sky. Only marginally dimmer, brilliant Vega shines lower in the northeast to east. Both stars climb throughout the month, along with their constellations. At 37 light-years distant, Arcturus anchors kite-shaped Bootes, the herdsman, while Vega, at 25 light-years, dominates the small constellation


In the second half of May, Spica—the only bright star in Virgo, the maiden—will be almost due south at nightfall, below and slightly west of Arcturus. Spica contains two stars, both larger than the sun, separated by just 11 million miles, or 12 percent of Earth's distance from the sun. These stars orbit their common center of mass in just four days. It's thought that their intense mutual gravity deforms both stars into an egg-like shape.

The moon begins the month in the morning sky. Just before dawn on the 3rd, it appears close above the eastern horizon, to the right of Saturn. After beginning a new cycle on the 7th, it visits the Gemini twin stars on the 12th; Regulus, in Leo, on the 15th; and Spica on the 19th. The night of the 22nd to 23rd, May's full moon traces a low arc across the sky.



"I would like to recognize all the amazing teachers that are implementing this program in Brandon-Evansville in the Early Childhood Family Education program, Pre-K and first grades. Also, the support from the B-E administration has been excellent," Berry added.

Surveys of families show that they are establishing reading routines within their homes. All the families involved say they now share books three times a week, and the duration of family-shared reading of at least sixty minutes weekly has increased from 50 percent to 92 percent. Use of at least four dialogic behaviors, such as asking their child questions about the text, has risen from 47 percent to 74 percent. Connecting to local libraries is integral to maintaining shared reading, which has increased from 34 percent to 63 percent.

There are so many benefits to all involved in the program. Children and families bond over books through a method called "book cuddling." Raising A Reader draws not only the young child into the time of book sharing but also draws in siblings, grandparents, and other family members, as the young child takes ownership of their red bag of books and wants to share them with everyone.

The community and partners feel like they are making a difference by contributing to

the success of the youngest community members and their families. Parents are especially thankful that books are being brought into their homes. They are also excited to learn with their children how to stop and ask questions while reading to their children.

The research clearly shows that strong, engaged families significantly impact children's educational and life outcomes. When families read together, they share more than stories. Reading together strengthens bonds between children and the caring adults in their lives.

Communities desire to be filled with healthy, strong families fluent in literacy and communication. The partners of this project and LCSC are to be commended for recognizing this and working to make it happen in North-Central Minnesota.

DNR wants people to report fish die-offs

The Minnesota Department of Natural Resources encourages Minnesotans to contact the state duty officer if they see evidence of a fish die-off in a lake or stream. Fish die-offs can result from a variety of natural and human causes.

To report fish die-offs, people should call the Minnesota duty officer at 651-649-5451 or 800-422-0798 (the duty officer line is staffed 24 hours per day, seven days a week). An early report facilitates timely water and fish sampling or other response actions, if needed. It's especially helpful to know what sizes and types of fish people see in a fish die-off.
